 Individual schools to adopt? What is the cost? 	The Food Dudes programme is usually commissioned through Public Health who sit in the Local Authority. We are in discussions currently with Public Health about the possibility of running the programme in a number of schools in Leeds. How and when this will be commissioned and paid for is yet to be decided, you can register an interest with the Health & Wellbeing Service.

 What are LCC doing on communications to parents directly and the wider community? Can we have template letter/marketing materials for parents of primary and nursery age children 	We are awaiting more information on a national communications campaign from the school food plan. A Leeds comms. group is looking at resources, in liaison with the Headteacher steering group. Some schools are already considering how they will target parents, i.e parent letters specific to their school or putting information in with admissions forms. The Health & Wellbeing Service will produce a letter template shortly for schools to access in the summer term. Schools will be informed on further resources that become available and how to access them.
 Will there be a blog or forum on the internet to share info to help the momentum for this? 	The school food plan is developing a dedicated online platform to share what works well. In the meantime there are case studies available on their website. One of the best ways of sharing information with progression is on twitter @schfoodplan & @schoolwellebing_
 Schools do not have access to LCC intranet so it is difficult to know who to contact about what and who is out there and able to provide help and support.  What support is available for additional equipment – fridge/cold serving cupboard for sandwiches. Reassurance please that no bias towards allocating funding to schools who use Catering Leeds 	Leeds City Council will be in touch to request kitchen and dining room audits similar to those that Catering Leeds have done in their school kitchens. Support will be available to complete this process. Then appropriate solutions will be discussed with the schools on a needs basis with indication from the audits.
• Will this become an Ofsted target?	Ofsted new subsidiary guidance states: Inspectors should consider the food on offer at the school and atmosphere of the school canteen. They should consider how lunch time and the dining space contribute to good behaviour and the culture in the school, including by spending time in the lunch hall, and ask school leaders how they help to ensure a healthy lifestyle for their children and, specifically, whether their dietary needs have been considered.
• What responsibilities do a Governing Body have in respect of this other than what they currently have. What will they have to report back on?	The termly schools census will be used from October 2014 to collect information on the take up of a midday meal by individual pupils. This will inform future revenue funding for school meals. There are no additional reporting / publication requirements that we are yet aware of.
• Will the free fruit still happen? Will we still charge for school milk or will this be free too? What about nursery children?	Free fruit and milk are covered under a different policy so will not be affected by this initiative. It does not apply to nursery children.
 How can we access the nutritional levels expected of our menus? 	The new food standards are available as a draft. <u>https://www.gov.uk/government/consultations/revised-</u> <u>standards-for-food-in-schools2</u> This means menus no longer have to be analysed by a computer programme
 Staff training? Special diets? 	Speak to your caterer about how kitchen staff will be trained for the changes they may face. The pilots advised training on new equipment and menus prior to September. Staff training: the Health & Wellbeing Service will be providing school staff training such as Lunch Time Supervisor training. Special diets: sending a letter out to parents to enquire whether their child has special diets and speaking to caterers to ask if they can meet this demand. Most caterers have a nutritionist that will assist with this.
 Can we get discounts on equipment if we buy together? (economies of scale) 	We will be establishing a procurement arrangement that will provide economies of scale for Leeds schools. Further information will be available.
