What is it?

Takeover Day is a national event organised by the Children's Commissioner for England, Maggie Atkinson. It gives children and young people the chance to work with adults and to get involved in organisational decision-making. Children and young people benefit from the opportunity to experience the world of work and make their voices heard, while adults and organisations gain a fresh perspective on the work they do.

When it is?

National Takeover Day takes place this on Friday 21st November 2014, however in Leeds we're promoting a '**Takeover Month'** to give organisations like yours more opportunity to participate.

What makes a successful takeover?

Takeover month is a chance for services and organisations to involve children and young people in decision making.

To ensure your takeover event is a success for everyone involved, you should decide on a meaningful task that will be interesting for children and young people to be involved in.

Examples of some previous takeover activities include:

Risk Assessment and safeguarding

To ensure the safety of children and young people during takeover, supervising staff responsible for the children and young people must have a current DBS check and a risk assessment must be completed prior to the session. Please also ensure that you have the correct school / parental consent for the children and young people involved. The safeguarding of children and young people is the responsibility of the organisation / service who are being 'taken over'. More guidance available here. **Example risk assessment:**
